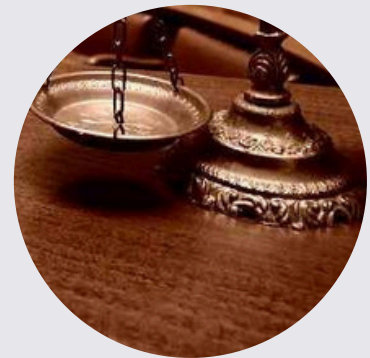
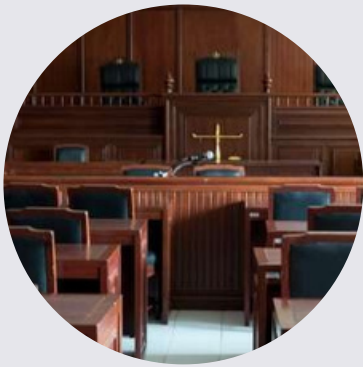

The number of members allowed in a team is 3.
