# Call for Papers

## Submission Guidelines

### **1.AUTHORS**

Paper can be submitted by an Author or with one co-author. **(Maximum of two authors)**.

### **2.ABSTRACT**

- Prospective authors must submit an abstract of **250-500 words** outlining the research question, methodology, and key arguments of the paper.
- Abstract shall contain **4- 5 keywords**.
- **Abstract must adhere to 21st edition of Bluebook.**

### **3.FULL RESEARCH PAPER**

- Full papers should be between **3,000 to 4,000 words**, following academic standards.
- The main text should be in **Times New Roman font size 12** and **1.5 line spacing**.
- The footnotes should be in **Times New Roman font size 10** with single line spacing.
- **Full paper must adhere to 21st edition of the Bluebook.**

- The paper should be the original, unpublished work. Plagiarized submissions will be disqualified.

#### **4.LANGUAGE**

The paper should be written in English.

**Registration is mandatory.**

- **Presentation Format(offline/online):** Authors will have 7 minutes to present their papers, followed by question-and-answer session with the audience.
- **Presentation Aids:** Projectors and other audiovisual equipment will be available for presenters. Authors are encouraged to prepare visual aids or slides to enhance their presentations.
- **Language:** Presentations should be delivered in English.
- Physical presenters should carry three hard copies.
