The Justice T.S.Krishnamoorthy Iyer Fellowship & Justice K. Sankarasubbier Fellowship is an initiative by the Kerala High Court Advocates' Association (KHCAA) supported by Justice TSK Iyer Family aimed at empowering and supporting first generation lawyers practicing before the High Court of Kerala. This fellowship provides a platform to encourage professional excellence and recognize promising talent in legal field. The Justice T.S.Krishnamoorthy Iyer Fellowship will be awarded to Five Female Advocates and the Justice K. Sankarasubbier Fellowship will be awarded to Five Male Advocates.

### **About Justice TSK Iyer**

Justice T S Krishnamoorthy Iyer began his legal practice in the year 1935 and hails from a family of distinguished judges and administrators. In 1965, he was appointed as the Advocate General of Kerala followed by his elevation as the Judge of the High Court of Kerala in the same year. He retired from the Kerala High Court in the year 1973 and continued his legal practice as a Senior Counsel in the Supreme Court of India. He served as a member of the 8th Law Commission of India from 1977 to 1979. Justice T.S. Krishnamoorthy Iyer passed away on September 3, 1999.

### **About Justice K. Sankarasubbier**

Justice K . Sankarasubbier graduated from the Madras Christian College and perused law in the Madras Law college. He served in the Travancore judicial services and was later elevated as a Judge of the Travancore High Court. He
