NOTIFICATION

Appointment to the Post of Assistant Professor in Law

The National University of Advanced Legal Studies (NUALS), Kochi, invites application from eligible candidates for appointment to the following teaching post:

Eligibility:

- **A** i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University.
 - ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/Institutions subject to the fulfillment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;

- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency. The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

OR

B. The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Age: Not more than 50 years as on the date of notification, but relaxable in the case of persons who are already in service.

Scale of pay: At Academic Level 10 with rationalized entry pay of Rs. 57,700/- of the UGC Scale of pay.

Application Fee: Rs.1,500/- (Rs.750/- for SC/ST candidates). Fee should be remitted by way of Demand Draft drawn in favour of 'The Registrar, NUALS', payable at Ernakulam.

General Instructions:

- 1. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 2. The applications of those who are in service shall be forwarded through proper channel or with 'No Objection Certificate' from the present Employer.

- 3. The University reserves the right not to select or appoint any person, if the Selection Committee is of the opinion that none of the candidates is suitable for appointment.
- 4. No TA/DA shall be paid by the University for attending the Interview.
- 5. The qualification prescribed shall be as on the last date of receipt of application.
- 6. Applicants for the post of **Assistant Professor** will be short listed in accordance with the criteria envisaged in Table-3A of the UGC regulations 2018 and its amendments.
- 7. Only shortlisted candidates will be called for interview.
- 8. Rules of reservation as contemplated in the KSSR, shall be applicable.
- 9. Candidates claiming reservation have to produce Caste Certificate issued by the competent authority.
- 10. Natives of outside Kerala State will not be considered for the posts which come under community reservation quota.
- 11. The validity of the rank list as per the notification will be for a period of two years from the date of publishing the list.
- 12. <u>How to apply</u>: The prescribed application form can be downloaded from the University website, 'www.nuals.ac.in'. Duly filled in application, together with registration fee and one set of self-attested copies of Certificates to prove age, caste/community, qualifications, experience etc., should reach the Registrar, The National University of Advanced Legal Studies (NUALS), NUALS Campus, H.M.T. Colony P.O., Kalamassery, Kochi 683 503, on or before 14.03.2025.
- 13. Applications received after the due date and not in conformity with the prescribed qualifications will summarily be rejected.
