## WHY MOCK PARLIAMENT?

To Foster critical thinking, Enhance public speaking, and to deepen the understanding of democratic processes among students.

## THE STRUCTURE OF THE MOCK PARLIAMENT 2025

### WILL BE:

1. OATH OR AFFIRMATION – Oath of the member elected through bye election in Krishnanagar WB constituency.



**2. QUESTION HOUR**- Selected starred questions will be raised by members of opposition in an order by which the speaker calls, this may be followed by 1-2 counter question but the total time is 60 minutes and tentatively each question may take up only 5-6 minutes

**3. CALLING ATTENTION MOTION** - A member from the opposition will call the attention of ruling party to the issue of 'Prevention of Sexual Harassment(POSH) Act'. The discussion and debate will take place for 30 Minutes.

**4. INTRODUCTION OF BILL**- The Minister for Law will introduce GOVERNERS REGULATIONS OF POWER AND FUNCTIONS BILL as first reading. Then the floor will be open for discussion. This session is scheduled for one hour.



## **MAJOR POINTS TO REMEMBER [Dos & Don'ts]**

### **Dos**

- ✓ Come up with pan India facts and do proper research about the political ideology the party is propagating towards the issue.
- ✓ You very well have the power of expression to express your opinion strongly but the final discretion is with the speaker
- ✓ There won't be individual recognition for speaking, the candidates have to grab the opportunity among themselves
- ✓ The participants will be marked with their chest number, kindly remember to highlight your chest number throughout the session of the house



✓ You are allowed to use downloaded materials; you may bring paper or reports or anything of such sort


✓ You are participating in the business of the house in your own names. However, make sure that you stick to the ideology of the political party you represent. Moreover, the members may bring into notice, the scenario in your constituency or state during the first reading of original bill or calling attention motion.

✓ Once the business of the house is over, the selected members of the Mock Parliament have to respond to the questions raised by the student journalists.



## **DON'Ts**

- ✓ Don't cross the floor once the house is in session
- ✓ There should be no discussion on sensitive policy matters affecting the relations of our country with foreign friendly Governments or which will prove embarrassing for the country and its present-day Government.
- ✓ Internet will not be allowed in the session, if anyone is found using, he/she will be disqualified
- ✓ No member should rise or leave the House when the Speaker is addressing the House. "The Speaker is always to be heard in silence".
- ✓ The members don't have to refer to the personality, opinion, or individual stand of the current MPs of your allotted constituencies. Because, in Mock Parliament you are not representing any real person.
