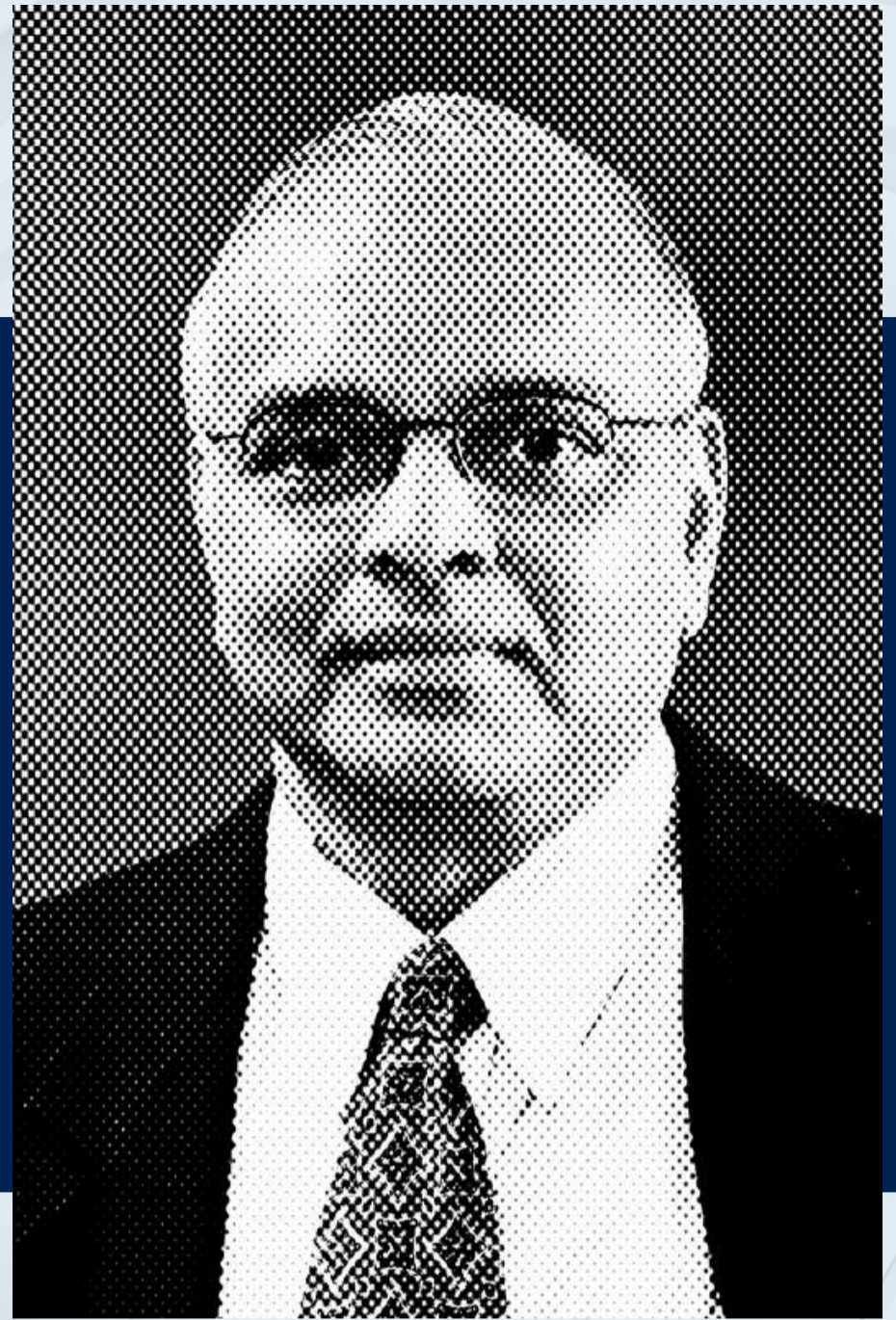

QUICK GLANCE AT RULES

1. The name of the competition shall be SHRI NJ YASASWY MEMORIAL 11th MOOT COURT COMPETITION, 2026.
2. The competition shall consist of five rounds: two Preliminary Rounds, Quarter-Finals, Semi-Finals, and Finals, based on the Moot Proposition.
3. In the Preliminary Rounds 1 and 2, each team shall argue for both sides. The top eight teams, based on aggregate scores from both Preliminary Rounds, shall qualify for the Quarter-Finals.
4. The Quarter-Finals shall be conducted on a knockout basis, with four teams advancing to the Semi-Finals.
5. The Semi-Finals shall be knockout rounds, with two teams advancing to the Finals.
6. Each team must submit soft copies of memorials for both sides in both WORD and PDF format by 11:59 PM IST, 23 August 2026, through [Memorial Submission Link](#). Soft copies of memorials sent via mail are not accepted. Three hard copies of memorial on each side must be submitted during physical registration necessarily at ICFAL Law School, IFHE Hyderabad on 4th September, 2026.
7. Clarification requests must be submitted by 09th August, 2026 via Clarifications form ([link](#) for the form) and clarifications sought via email are not considered.
8. Teams must finalize and register their Speakers and Researcher before registration. No changes shall be permitted thereafter.
9. All participants shall attend the competition in formal attire.
10. Registration fees are non-refundable.
11. Certificates shall be distributed only during the Valedictory Ceremony. No certificates shall be sent by post.

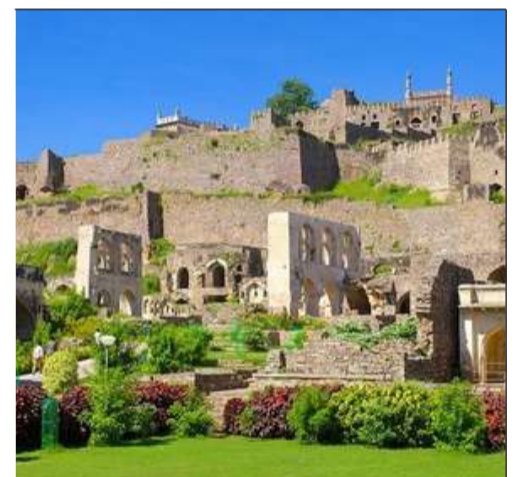

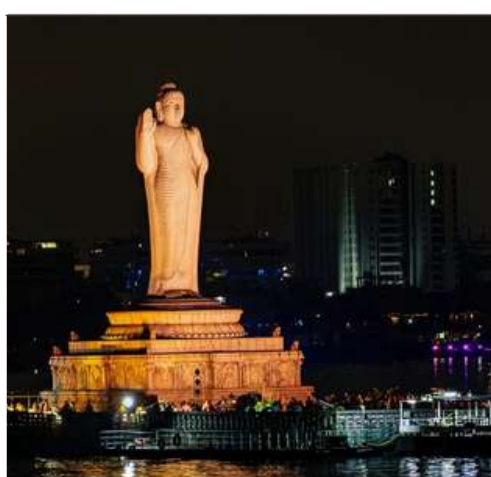
