**PwBD candidates having disability of minimum 40 % are only eligible to apply. The disability conditions falling under the category 'likely to improve' under temporary disability category are not eligible for reservation. The conditions i.e. progressive, non-progressive or not likely to improve are eligible for reservation**

**Candidates must upload Certificate of Disability in the prescribed format as per Rule 18 (1) of Rights of Persons with Disabilities Rules, 2017 (Form V, Form VI or Form VII) as applicable issued by the Competent Authority and forward copy of the Disability Certificate along with hard copy of the application.**

**Suitability of the in terms of functional requirements against the above identified post will be examined by the Selection Committee before selection.**

## III. GENERAL INSTRUCTIONS, ESSENTIAL INFORMATION, AND CLARIFICATIONS

1. Applications are to be submitted through on-line mode through the link <https://curec.samarth.ac.in>.
2. The qualifications and other conditions prescribed in the present advertisement are subject to the regulations/norms stipulated by GoI/MoE/UGC/ University from time to time.
3. The posts notified in this advertisement includes existing as well as anticipated vacancies.
4. **The eligibility and qualifications prescribed shall be reckoned as on the closing date of online application.** It shall be the responsibility of the candidate to ascertain his/her own eligibility for the post in accordance with the prescribed qualifications, experience, etc before submitting the application. Changes in Regulations on qualifications, experience, age, calculation/application of API scores, etc. issued by the UGC, subsequent to this Advertisement will become mandatory from the respective dates of effect prescribed. Applicants are advised to visit the University/UGC/Ministry of Education websites for latest revision/changes which will be applicable at the time of interview.
5. Suppression of factual information, supply of fake documents, providing false or misleading information or canvassing in any manner on the part of the candidates shall lead to disqualification. Any time even after appointment if it is noticed that the candidate does not possess the eligibility prescribed in the Notification or that the claim made by him/her with respect to the qualifications/experience/other credentials are false or misrepresented, then his/her appointment shall be terminated forthwith. The candidate shall be held solely responsible for the same and the consequences thereupon.

7. Applications will be summarily rejected if hard copy of the same is not received with all the supporting documents on or before the last date of receipt of application.
8. All the information/addendum/corrigendum etc subsequent to this Advertisement, if any, will be uploaded on the website only. Candidates are advised to regularly visit the university website [www.cukerala.ac.in](http://www.cukerala.ac.in) and CU Chayan Portal <https://curec.samarth.ac.in> for updates. The university will not be responsible for any information which is unnoticed by the candidates. The University will issue call letters to the shortlisted candidates and other correspondences through email only. Queries/correspondences from the candidates, if any, are to be addressed to email-[recruitmentcell@cukerala.ac.in](mailto:recruitmentcell@cukerala.ac.in) only. Reply to the queries raised by the candidates will be provided by considering the merit of the query.
9. Candidates must upload valid SC/ST/OBC (Non-creamy layer Certificate)/PwBD (as applicable) issued by the Competent Authority and forward copy of the Certificate along with Hard Copy of the application.
10. Applicants are advised to submit the applications well in advance without waiting for the last date to avoid postal delay or delay due to technical or other unforeseen events or circumstances. The university will not be responsible for any delay in submission of application at any stage.
11. Candidates already in service must submit Endorsement by the Employer in the prescribed format. Candidates who are unable to upload NOC/ Endorsement by the Employer may upload an undertaking stating that the NOC/Endorsement by the Employer will be submitted along with hard copy of the application or at the time of interview, if called for. Candidates failing to produce NOC will not be permitted to attend the interview.
12. Online Application fee is Rs.2000/-. Women candidates and candidates belongs to SC, ST & PWD categories are exempted from payment of application fee. The online application processing fee is non-refundable, and no enquiries shall be entertained in this regard by the University. The fee shall be remitted through online (Credit/Debit Cards, NEFT, Net Banking etc). A copy of the transaction receipt should be enclosed along with the application.
13. A relaxation of 5% (55% to 50%) shall be provided at the Graduate and Masters level for the Scheduled Castes/Scheduled Tribes/Persons with Disability (PwBD/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record. The eligibility of 55% marks or an equivalent grade in a point scale wherever grading system is followed and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark.
14. A relaxation of 5% i.e, 55% to 50% to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19<sup>th</sup> September, 1991.
15. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid. Candidates must submit certificate of conversion of grade to percentage issued by the concerned degree awarding University.

16. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching / research experience for appointment to the teaching positions. Further, the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience.
17. **Candidates claiming previous service / experience should submit certificate fulfilling the conditions as per Clause 10 of UGC Regulations, 2018 as applicable. The Experience Certificate (s) submitted by the candidates should clearly specify the detailed break-up of experience with period of service, scale of pay, nature of appointment (Regular, Contract, Temporary etc), Scale of pay, nature of Organisation (State Govt, Central Govt, PSU, Autonomous Body, Aided, Private etc.). (Offer letters, Appointment Orders, Joining Report, Relieving Orders, etc., will not be considered as Experience Certificate).**
18. The proof of Peer Reviewed Journal status, Impact Factor, Authorship Claim etc. should be provided with valid documents failing which scores will not be allotted as per the claim. University will not be responsible for any mistakes made by the candidates due to the lack of valid proof.
19. Candidates possessing Foreign Degrees should submit Equivalence Certificate issued by the Association of Indian Universities (AIU) at the time of interview, if called for
20. Candidates, who have obtained degrees or diplomas or certificates for various courses from any institution declared fake/derecognized by the University Grants Commission at the time of obtaining the degree shall not be eligible for being considered for recruitment to the post advertised.
21. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received is large and/or where it will not be convenient or possible to interview all the candidates, the University at its discretion may restrict the number of candidates to a reasonable limit on the basis of higher qualifications/experience than that prescribed in the Advertisement.
22. If selected and appointed, the candidate shall be required to produce a medical fitness certificate from the medical board as specified by the University.
23. Outstation candidates (beyond 30 Km) belonging to SC/ST/PwBD categories called for interview will be reimbursed single second class railway fare from station to station towards journey expenses on production of ticket and proof of category (as per Gol rules). The above mentioned concessions shall not be admissible to those SC/ST/ PwBD candidates who are already in Central/ State Government Services.
24. The faculty appointed to the designated post shall undertake to teach subjects/courses in the Undergraduate (UG), Postgraduate (PG) or other programmes of the University as assigned by the competent authority from time to time.
25. The faculty appointed to the designated post shall be required to serve at any place/Center as notified by the Central University of Kerala from time to time. The faculty appointed to the designated post shall be assigned with academic or administrative responsibilities in addition to their regular teaching and research activities.
26. If selected, the terms and conditions of appointment shall be communicated to the selected candidate in the form of 'Offer of Appointment'. If the candidate does not accept the terms and conditions mentioned in the offer of appointment within the stipulated time mentioned in the offer letter, the offer shall be treated as withdrawn.
27. At the time of appointment, a 'Service Agreement' shall be executed between the University and the employee concerned and a copy of the same shall be kept in the University. Such service agreement shall be duly stamped and notarised as per the rates applicable.

28. The appointment of a candidate shall be subject to verification of character and antecedents by the competent authority. Until the verification of character and antecedents reports are received, the appointment shall be treated as provisional. In case the report(s) with regard to his/her conduct, character, antecedents, etc., is found to be unsatisfactory, the appointment shall be cancelled/terminated forth with as per applicable rules.
29. The person appointed against any post shall be governed by the Act/Statutes/Ordinances/Rules of the University and also the CCS (Conduct) Rules,1964 and CCS (CCA) Rule,1965 or any other rules of the Government of India, as amended from time to time and any other rule/resolution prescribed specifically for maintaining the conduct of the employees by the Executive Council of the University.
30. The pay of the selected candidates will be fixed as per the rules and regulations issued by the UGC/Government of India from time to time.
31. The appointed candidates shall be governed by the National Pension Scheme (NPS) and its amendments issued from time to time.
32. The University reserves the right to: **(a)** withdraw the Notification at any time without assigning any reasons to this effect **(b)** to fill or not to fill up the post advertised for any reasons whatsoever.
33. No interim queries regarding interview/selection will be entertained.
34. Canvassing in any form shall invite disqualification.
35. In case of any disputes arising out of this notification, the jurisdiction shall be the Hon'ble High Court of Kerala.
36. Any errors and omissions detected in the Advertisement are subject to rectification by the University. In case of any ambiguity pertaining to the eligibility criteria for any post, dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final. In case of any inadvertent mistake in the process of selection which is detected at any stage even after the issuance of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
