CALL FOR PAPERS

1. ARTICLE SUBMISSION AND PRESENTATION

Abstract & Article Submission Guidelines

Faculty members, early-career researchers, registered Ph.D. scholars, students from universities and research institutions, as well as policymakers & industry professionals, are encouraged to apply.

Abstract Submission

Authors are required to submit an abstract of 250–300 words. The abstract should clearly state the paper's title and outline the research objectives, methodology, and/or preliminary findings.

In the submission file, authors must include a cover page (including the presenter's & author's name, affiliation, and email address).

All submissions will undergo peer review, and authors will be informed of the acceptance or revisions of their abstracts.



Full Paper Submission

Authors of accepted abstracts will be required to submit a full paper. The manuscript should typically be between 6000–8000 words, inclusive of references, tables, and figures.

- The plagiarism level must be below 10%, with AI-generated content strictly avoided.
- Manuscripts must be prepared and submitted in MS Word format.
- A consistent academic citation style must be followed throughout the paper. The authors are expected to ensure that submissions are original and adhere to academic integrity.

Submission of the full paper is mandatory for conference presentation. All full papers will be reviewed for academic quality and relevance, and authors will be notified regarding their acceptance.

Authors who fail to submit the full paper in due time will not be included in the conference programme.

2. POSTER SUBMISSION AND PRESENTATION

Objective:

Poster presentations are intended to facilitate visual engagement, concise communication, and networking opportunities among participants.

Structure:

Special stands will be available for poster presentations of any idea or short communication (with clear, concise content; engaging visuals; a readable layout; professional design; handouts, or flyers). It will be an elevator pitch (a short, engaging summary of any article) delivered by the author during the conversation with the attendees.



3. PANEL DISCUSSION

Objective: This session aims to facilitate multidisciplinary dialogue for engaging conversation, and to foster an open and inclusive discussion with an encouraging interaction with a broader theme, which will be conducted with the general public & industry leaders.

Structure:

Duration: 1.5 to 2 hours.

Interactive Q&A: In an interactive session, the live chat will be open to all, and in-person attendees can ask questions or share suggestions.

4. PUBLIC DIALOGUE

Objective: To provide a platform for a multi-purpose interaction on key topics, the expert's opinion or debate, challenging ideas, and engaging the audience in GST 2.0 will be considered.

Structure:

Duration: 1 to 5 hours.

Moderators: A subject expert will serve as a moderator, asking Q&A to prompt discussion and guide the conversation.

Panellists: Various sector experts will strengthen Indian self-reliant architecture strategies through a progressive and growth-oriented tax policy for releasing the vision of Vikshit Bharat 2047.
